To achieve the proposed objectives, the quality and environmental management system established by TECNITEX, based on the reference standards UNE-EN-ISO 9001:2015 and UNE-EN-ISO 14001:2015, is supported by the following basic pillars established by the Management:

- Compliance with the requirements of the **applicable legislation** and regulations to our activity, the commitments acquired with clients and interested parties and all those internal regulations or action guidelines to which TECNITEX is subject.
- Motivate and train all personnel working in the organization, both for the correct performance of their job and to act in accordance with the requirements imposed by the reference standards, providing an adequate environment for the operation of the processes and the **respect for the environment**.
- Maintenance of fluid **communication** both internally, between the different levels of the company, as well as with clients and other interested parts.
